Sunil Nath Advocates for the petitioner and it appearing from the report that the proposed arrangement has been approved unanimously by ordinary shareholders of the petitioner company present and voting in person or by proxy & the affidavit dated 28th October, 1997 submitted on behalf of Regional Director (Northern Region), Kanpur and after hearing the O.L.authorised on behalf of the Regional Director.

This Court doth hereby sanctions the scheme of arrangement as annexed alongwith the petition as Annexure A & set forth herein as Schedule A and doth hereby declare to be the same binding on ordinary shareholders of the above named company and also on the said company. And this court doth further order:

1. MEMORANDUM OF ASSOCIATION*
OF
SIL INVESTMENTS LIMITED

- I. The name of the Company is SIL Investments Limited
- II. The registered office of the Company will be situated in the State of Rajasthan
- III. The objects for which the Company is established are :-

(A) MAIN OBJECTS OF THE COMPANY TO BE PURSUED (AFTER DEMERGER OF ITS TEXTILES DIVISION APPROVED BY THE HON'BLE HIGH COURT OF RAJASTHAN BENCH AT JAIPUR ON 12TH MAY, 2006)

- (1) To carry on the business of investment company and for that purpose to invest in and acquire hold and deal in shares, stocks, debentures, debenture stocks, bonds, obligations and securities issued or guaranteed by any body corporate carrying on business in India or elsewhere and debentures, debenture stocks, bonds, obligations and securities, issued or guaranteed by any Government State dominion, sovereign, ruler, commissioners, public body or authority, supreme, municipal local or otherwise whether in India or elsewhere.
- (2) To acquire any such shares, stocks, debentures, debenture stock, bonds, obligations or securities, by original subscriptions tender, purchase, exchange or otherwise and to subscribe for the same, either conditionally or otherwise, and to guarantee the subscription thereof and to exercise and enforce all rights and powers conferred by or incidental to the ownership thereof
- (3) To carry and otherwise dispose of exchange, transfer or alienate any of the Company's investments and those mentioned in (1) and (2) above.
- (4) To invest in and otherwise deal in gold, silver and other precious metals and all articles and merchandise of all kinds either ready or for forward delivery.
- (5) To carry on all their respective branches the business of general finance and investment.
- (6) To promote, form or acquire company(s) industry(s) and to take purchase or acquire shares or interest in any company and to transfer to any such company, any property of this company and to take or otherwise acquire, hold and dispose of or otherwise deal in and invest in any shares, debentures and other securities in or of any company or companies either out of its own funds or out of funds it might borrow by issue of debentures or from bankers or otherwise and to subsidise or otherwise assist any such company.
- (7) To invest money (not amounting to banking business) on personal security or on the security, of leasehold and freehold land, shares securities, stock merchandise and other property and assets and generally to lend and advance money to such persons, firms, or Companies and upon such terms and subject to such conditions as may seem expedient.

- (8) To hold and lease immovable properties and purchase for investment and resale and to deal in land, house and other property of any tenure and any interest thereon and to create, sell or deal in freehold and leasehold property.
- (9) To carry on the business of badla transaction in whatever name or form as permitted by law as in force from time to time.
- (10) To carry on the business of traders and merchants in all types of commodities and articles of consumption in India or elsewhere and enter into transaction for purchase and sale of various commodities for future delivery.
- (11) To carry on the business as broker and trader in all commodities and commodity derivatives and to act as market maker, finance broker, sub-broker, underwriters, sub-underwriters, providers of services for commodity related activities. And to do the business of commodity warehousing, processing and consumption. To apply for and obtain registration as commodity broker or Member of any Commodity Exchanges any where in India and abroad. To buy, sell, take hold deal in, convert, modify add value transfer or otherwise dispose of commodities and commodity derivatives and to carry on the above business in India and abroad for and on behalf of the company as well as others. To do the business of commodity (including commodity derivatives) broking, trading and holding.

(B) OBJECTS INCIDENTAL OR ANCILLARY TO THE ATTAINMENT OF MAIN OBJECTS

- (1) Subject to provisions of the Act, to lend, invest or deal with the money either with or without interest or security, including in current or deposit account with any bank or banks, other person or persons and also in investment in shares, securities, bonds and debentures, upon such terms, conditions and manner as may from time to time be determined and to receive money on deposit or loan upon such terms and conditions as the Company may approve provided the Company shall not do any banking business as defined under the Banking Regulations Act, 1949.
- (2) To borrow or raise or secure the payment of money from any bank or banks or any other person or persons for the purpose of the Company's business in such manner and on such terms and with such rights, powers and privilege as the Company may think fit and particularly by issue of or upon bonds, debentures, bills of exchange, promissory notes or other obligation or securities of the Company and with a view thereto mortgage or charge the undertaking and all or any of the immovable and moveable properties, present or future, and all or any of the uncalled capital for the time being of the Company and to purchase, redeem or pay off any such securities.
- (3) To enter into partnership or arrangement for sharing the profits or joint venture with any person or persons or company carrying on or about to carry on any business capable of being conducted so as directly or indirectly to benefit this Company and to acquire or join in acquiring any such business, as covered by the objects clauses.
- (4) To sell, improve, manage, develop, exchange, lease, mortgage, dispose of, turn to account or otherwise deal with all or any part of the undertaking property, investments and rights of the Company.

- (5) To apply for, purchase or otherwise acquire, any patent, trade mark, brevets, d'invention, licences, concessions, protections, rights, privileges and the like conferring any exclusive or non-exclusive or limited rights to any secret or other information as to any invention which may seem capable of being used for any of the purposes of the Company or the acquisition of which may seem directly or indirectly of use or benefit to the Company or may appear likely to be advantageous or useful to the Company and to use, exercise, develop or grant license, privileges in that respect or otherwise turn to account the property, right or information so acquired and to assist, encourage and spend money in making experiments, tests improvements of any invention patent and right which the Company may acquire or propose to acquire.
- (6) To establish and support or aid in the establishment and support of association, institutions, clubs, societies, funds, trusts, and conveniences calculated to benefit employees or ex-employees of the Company or the dependents or the connections of such persons or subject to the provisions of Companies Act to subscribe, donate or guarantee money for any charitable, national, political, religious, benevolent general or useful object or fund, or for any purpose which may likely, directly or indirectly, further the objects of the Company or the interest of its members or business.
- (7) To distribute among the members of the Company dividends including bonus shares (including fractional share certificates) out of profits accumulated profits or funds and resources of the Company in any manner permissible under law.
- (8) To acquire or amalgamate with any company or companies having objects altogether or in part similar to those of this Company or any other company.
- (9) To open branches in India and elsewhere and to get the company registered in foreign country and adopt such means of making known to the public the business or the products of the Company as may seem expedient and in particular by advertising in press, by circulars and publication of books and periodicals.
- (10) To communicate with Chambers of Commerce and other mercantile and public bodies throughout the world and concert and promote measures for the protection of the trade, industry and persons engaged therein.
- (11) To subscribe to, become a member of, subsidise and co-operate with any association, whether incorporated or not, whose objects are altogether or in part similar to those of the Company, and to procure from and communicate to any such association, such information as may be likely to forward the objects of the Company.
- (12) To vest any real or personal property rights or interest acquired by or belonging to the Company in any person or company on behalf of or for the benefit of the Company with or without any declared trust in favour of the Company.
- (13) To enter into any arrangements with any Government or any authority, supreme, municipal, local or otherwise that may seem beneficial to any of the Company's objects and to apply for, procure and obtain any Act of Parliament, privilege, concessions, licence or authorization of the Government of any other

authority local or otherwise for enabling the Company to carry any of its objects into effect or for extending any of the powers of the Company and to carry out, exercise and comply with any such Act, privilege, concession, licence or authorization and to carry out and implement the provisions of the Foreign Exchange Regulation Act, 1973.

- (14) To pay any premiums or salaries and to pay for any property, right or privileges acquired by the Company or for services rendered or to be rendered in connection with the promotion, formation of or the business of the Company or for services rendered or to be rendered by any person, firm or body corporate in placing or assisting to place or guaranteeing the placing of, any of the shares of the Company or any debentures, debenture stock or other securities of the Company or otherwise either wholly or partly in cash or in shares, bond, debentures or other securities of the Company, and to issue any such shares either as fully paid up or with such amount credited as paid up thereon as may be agreed upon, and to charge any such bond, debentures or other securities upon all or any part of the property of the Company.
- (15) In the event of winding up to distribute all or any of the property of the Company amongst the members in specie or kind or any proceeds of sale or disposal of any property of the Company but so that no distribution amounting to a reduction of capital be made except with the sanction(if any) for the time being required by law.
- (16) To make donations to such persons and in such cases and either of cash or other assets as the Company may think directly or indirectly conducive to any of its objects or otherwise expedient.
- (17) To undertake, carry out, promote and sponsor, rural development including any programme for promoting the social and economic welfare of or the uplift of the public in any rural area and incur any expenditure on any programme of rural development and to assist execution and promotion thereof directly or through an independent agency or in any other manner. Without prejudice to the generality of the foregoing, "programme of rural development" shall also include any programme for promoting the social and economic welfare of or the uplift of the public in any rural area which the Board of Directors of the Company (the Board) consider it likely to promote and assist rural development, and that the words "rural area" shall include such areas as may be regarded as rural area under "rural area" shall include such areas as may be regarded as rural area under Section 35CC of the Income Tax Act, 1961 or any other law relating to rural development for the time being in force or as may be regarded by the Board as rural areas and the Board may at its discretion in order to implement any of the abovementioned objects or purposes, transfer without consideration, or at such fair or concessional value as the Board may think fit and divest the ownership of any property of the Company to or in favour of any public or local body or authority or Central or State Government or any public institutions or trusts or funds as the Board may approve.
- (18) To undertake, carry out, promote and sponsor or assist any activity for the promotion and growth of national economy and for discharging what the Board of Directors of the Company (the Board) may consider to be social and moral responsibilities of the Company to the public or any section of the public as also any activity which the Board consider likely to promote national welfare or social, economic or moral uplift of the public or section of the public and in such manner and by such means as the Board may think fit and the Board may without prejudice to the generality of the foregoing undertake, carry out, promote

and sponsor and activity for publication of any books, literature, newspapers, etc. or for organising lectures or seminars likely to advance these objects or for giving merit awards, for giving scholarships, loans or any other assistance to deserving students or other scholars or persons to enable them to prosecute their studies or academic pursuits or researches and for establishing, conducting or assisting any institution, fund, trust, etc. having any one of the aforesaid objects as one of its objects by giving donations or otherwise in any other manner as the Board may at their discretion in order to implement any of the abovementioned objects or the abovementioned objects or purposes transfer without consideration or at such fair or concessional value as the Board may think fit divest the ownership of any property of the Company to or in favour of any public or local body or authority or Central or State Government or an public institutions or trusts or funds as the Board may approve.

- (19) To do all or any of the above things in any part of the world as principals, agents, contractors, trustees or otherwise by or through trustees, attorneys, agents or otherwise and either alone or in conjunction with others and to establish offices, agencies or branches for carrying any of the aforesaid objects in India or elsewhere in the world and to undertake the management of any company or companies having objects altogether or in part similar to those of the Company.
- (20) To do all such other things as may be deemed incidental or conducive to the attainment of the above objects or any of them.
- (21) Subject to the provision Section 58A and 292 under Companies Act, 1956 and the Rules thereunder and the directions of the Reserve Bank of India from time to time, to receive money or deposit on interest or otherwise with or without security from companies, firms or persons, whether moveable or immovable properties and to lend money and negotiate with or without security whether of moveable and immovable properties to such companies firms or person on such conditions as may seem expedient and to guarantee the performance of contracts by any person, company or firm provided that the Company shall not carry on the business of banking.

(C) THE OTHER OBJECTS

- (1) To carry on the business of manufacturers, processors, jobbers, including doing the job work for others and getting the job work done from others, importers, exporters, buyers, sellers of and dealers in all kind of fabrics and textiles, industrial fabrics, tapes, ropes, cord, twines, canvas, territowels, durries, newars, parachutes, carpets, rugs, blankets, tarpaulin, linens worsted stuff and other products as are prepared or manufactured from nylon, polyester, acrylic, rayon, silk, artificial silk, linen, cotton, wool, jute and any other synthetic, artificial and natural fibres including fibre glass and to treat and utilise any waste arising from any such manufacture, production or process.
- (2) To carry on all or any of the trades or business of preparing, spinning, doubling, weaving, scouring, sizing, bleaching, colouring, dyeing, printing, finishing and processing, working or manufacturing in any way whatever, cotton, linen, wool, silk, flex, hemp jute, artificial silk, rayon cloth, man made and other fibrous, artificial chemicals or synthetic or textile substance to treat and utilise and deal in any waste arising from any such operations and the buying and selling of and dealing in all or any of the aforementioned substances.

- (3) To carry on the business of manufacturing, buying, selling, exchange, importing, exporting, converting, altering, processing, or otherwise handling or dealing in cotton yarn, silk yarn, worsted or shoddy woolen yarn, rayon yarn, namely viscose, filament, rayon, continuous filament rayon, or artificial silk yarn, acrylic fibres, polyvinyl, alcohol fibre, cotton fabrics, all synthetic fabrics or fibres whatsoever for textile use staple, fibre, staple fibre, yarn, spun, rayon and any other fibrous or textile material whether an agricultural or animal or natural or chemical or synthetic product or its by-products or substances or substitutes for all or any of them of yarn or yarns for textile or other uses and to treat and utilise any waste arising from any manufacture, production or process.
- (4) To carry on the business as drapers and dealers of furnishing fabrics in all its branches as costumiers, readymade dressers and mantle maker silkmercer, makers and supplier of clothing, lingerie and trimmings of every kind, furrics, drapers, haberdashers, millieners, hosiery gloves, lace makers, rope makers, felt and tarpauline makers, and feather dressers.
- (5) To carry on the business of spinners, weavers, manufacturers, ginner, balers and pressers of Cotton Kapas, yarn, Cotton waste, Yarn waste, Hemp, Jute and any other fibrous material and the cultivation thereof, and the business of buyers, sellers and dealers of Cotton, Kapas, Cotton waste, Yarn waste, Hemp, Jute, and any other fibrous material, oil seeds, and any other seeds and produce and of any goods or merchandise whatsoever and to transact all manufacturing or treating and preparing processes and mercantile business that may be necessary or expedient and to purchase and vend the raw material and manufactured articles, and to carry on or be interested in the business of ginning and pressing factory proprietors.
- (6) To purchase or contract, for immediate or future delivery, kapas, raw cotton, wool, silk, hemp, jute, rags, yarns, cloths of various fibres, articles, irons and other metals and all stores and material, chemicals and things necessary or useful or ginning, spinning, weaving, manufacturing, dyeing, printing and bleaching purposes, also all machinery, plant, stores, material and things necessary or useful for the purposes of the company and if deemed expedient by the Directors to sell back, re-sell or to send for sale to any part of India or elsewhere all or any of the above mentioned machinery, plant, materials, produce, metals, articles and things.
- (7) To carry on the business as manufacturers, producers, processors, bleachers, spinners, importers, exporters, buyers, sellers and dealers in all kind of thread yarn and fibres, whether synthetic artificial, natural, nylon, polyester, acrylon, rayon silk, artificial, linen, cotton, wool, jute and any other fibre or fibrous materials, allied products, by-products for all substitutes all or any of them, wool combers, worsted spinners and to treat and utilise any waste arising from any such manufacture, production or process.
- (8) To carry on all or any of the trades or business of preparing, spinning, doubling, weaving, scouring, sizing, bleaching, colouring, dyeing, printing, finishing and processing, working or manufacturing in any way whatever, cotton, linen, wool, silk, flex, hemp jute, artificial silk, rayon cloth, man made and other fibrous, artificial chemicals or synthetic or textile substance to treat and utilise and deal in any waste arising from any such operations and the buying and selling of and dealing in all or any of the aforementioned substances.

- (9) To carry on the business of manufacturing, producing, processing, buying, selling, supplying, exporting all kind of fabrics and other fibrous material, clothes, dressing materials, uniform, ready made garments, apparels, carpets, blankets, woven bags, hosiery, knitted goods, home furnishing.
- (10) To do all or any business or activity or deal in any goods of any description whatsoever as principals, agents, distributors, importers, exporters or otherwise and establish any purchasing, selling or distribution organisation or agency for the aforesaid objects.
- (11) To carry on the business of buying, selling, leasing and hire purchase finance company to provide on lease or hire purchase basis all kinds of engineering products, plant, machinery and equipments, office and industrial machinery, electrical and electronic products, rubber and rubber products, tea and plantation products, automobiles and its accessories and spare parts, mining and mineral exploration equipments, paper and paper products, and all kinds of raw materials whether natural or man-made, forest products, industrial products, agricultural implements and produces, wood articles, metals and ores, mineral and petroleum products, industrial and other gases, alcohols, edible and non-edible oils and oil-seeds, fats, soaps and detergent, adhesives, consumer goods, household goods, furniture, vehicles, bullion, jewellery, hard wares, and stores, natural and manmade fibres, textiles of all kinds, ready-made garments and any products of cotton, synthetics or natural yarn, cement, plastics, fertilisers, chemicals, basic, intermediate or otherwise, building materials and all other machinery, equipment goods and materials required for the aforesaid articles and things.
- (12) To carry on the business of planters, cultivators, manufacturers, buyers and sellers of tea, tea seed, coffee and in this connection to purchase, take on lease or in exchange or otherwise acquire any lands, tea gardens, plantations and property as the company may think necessary or convenient for its business and to form, open out, work and carry on the business of a tea estate or tea estates on any lands to acquire, construct, and maintain factories, establishments, works, buildings and erections for all or any of the purposes aforesaid, and to acquire or make machinery, implements and articles required to be used for any such purposes, to carry on as, principals or agents in any branch of agricultural, manufacturing or mercantile for which the Company's lands, tea gardens, establishments, property and employees may be conveniently applicable and to carry on all such business connected with the acquisition, hiring, leasing, planting, irrigation and cultivation of lands and the rendering merchantable and disposing of the produce thereof as are usually or may conveniently be associated with the plantation and cultivation of tea gardens, and the manufacture, export, and sale of tea or any other produce of the soil.
- (13) To carry on the business of iron masters, steel makers, steel converters, manufacturers of ferromanganese, colliery proprietors, coke manufactures, miners, smelters, engineers, tin plate makers and iron founders and to search for, get, work, raise, make merchantable, sell and deal in iron, coal, ironstone, limestone, manganese, ferro-manganese, magnesite clay, fire clay, brick earth, bricks, and other metals, minerals and substances and to manufacture and sell briquettes and other fuel, and generally to undertake and carry on any business transaction or operation commonly undertaken or carried on by explorers, prospectors or concessionaires and to search for, win, work, get,

clacine, reduce amalgamate, dress, refine and prepare for the market any quartz and ore and mineral substance and to buy, sell, manufacture and deal in minerals and mineral products, plant and machinery and other things capable of being used in connection with mining or metallurgical operations or required by the workmen and other employed by the Company.

- (14) To carry on the business of producers, manufacturers, purchasers, refiners, importers, exporters, sellers of and dealers in cement, asbestos products, firebricks, coke, refractories articles, lime and limestone, plasters, artificial stone and materials of every kind used in the manufacture thereof, whiting clay, gravel, sand, sacks, bricks, tiles building materials analogous to or connected therewith and compounds, products and bye-products or preparation allied thereto and the business of miners, metallurgists, builders, contractors and to purchase and vend all materials raw processed or otherwise and all articles in any way connected with the aforesaid business and in connection therewith to take on lease or acquire, erect, construct, establish, operate and maintain cement factories, quarries and collieries, workshops and other works.
- (15) To purchase, manufacture, produce, grow, refine, prepare, import, export, sell and generally to deal in sugar, sugar-cane, sugar beets, mahua, palms, gur, jaggery, molasses, syrups and alcohol and all products or bye-products thereof and food products generally and in connection therewith to acquire, erect, construct, establish, operate and maintain sugar or other refineries, buildings, mills, factories, distilleries and other works and to carry on and work the business of growing, cultivating or buying every kind of sugar-cane, plants, fruits and seeds and vegetables produce or products of the soil and products of agriculture or husbandry; to prepare, manufacture, crush and render marketable any such sugar-cane plants, fruits, seeds, grain and produce and to sell, dispose of and deal in any sugar, sugar-cane plants, fruits, seeds produce and products in their prepared manufactured or raw state.
- (16) To carry on the business of manufacturers, importers, exporters and dealers in all kinds and classes of paper, board, corrugated board, corrugating medium and pulp and all kinds of articles in the manufacture of which in any form, paper, board or pulp is used and also to deal in or manufacture any other articles or things of a character similar or analogous to the foregoing or any of them or connected therewith and to purchase or otherwise acquire, settle, improve and cultivate forests, lands and properties of any tenure whatsoever with a view to producing, cultivating, growing timber, bamboo or other wood or any other material required for manufacture of paper, board and pulp.
- (17) To carry on all kinds of business of designers, manufacturers, processors, assemblers, dealers, traders, distributors, importers, exporters, agents, consultants, system designers and contractors for erection and commissioning or turn key basis or to deal in any other manner including, storing, packing, transporting, converting, repairing, installing, training, servicing, maintenance of all types, varieties and kinds of (i) electronic components, devices, equipments and appliances, (ii) telephone instruments, intercoms, accessories and components thereof for tele-communications (iii) radio communication equipments like receivers, transmitters, transreceivers, walkie talkie radio relay equipment, point to point communication equipments, antennas and associated equipments, single channel, multi-channel, fixed frequency, variable frequency, static mobile, airborne, shipborne equipments in HF, VHF, UHF and Microwave,spectrum, TV systems, receivers, transmitters, pattern generators

and associated equipments, amplifiers, oscillators, synthesisers, wave from generating, measuring and associated equipments, sonic, ultrasonic and radio frequency ranging and depth finding sonar and Telemetry coding and data transmission equipments, data acquisition, processing and logging equipments, calculators, computers, minicomputers and microcomputers, printers, readers, display terminals, facsimile transmitting and receiving equipments and systems, (iv) signalling, telecommunication and control equipments used in roads, railways, ship, aircrafts, ports, airports, railway stations, public places along with associated accessories and test rigs (v) instruments, testing equipments, accessories for repair, maintenance, alibration and standardisation of all the above items in laboratories, service centres, processing plants, manufacturing plants and at customers places.

- (18) To carry on the business of farming, horticulture, floriculture, sericulture, dairies, cultivators of all kinds of food grains, seeds, fruits, flowers and manufacturers, traders, exporters and sellers of and dealers in products of farming, dairy, horticulture, sericulture and pisciculture.
- (19) To manufacture, produce, refine, process, formulate, mix or prepare, enrich, mine, import or otherwise acquire, own, hold, use, mortgage, pledge, buy, sell, exchange, distribute, assign, transfer or otherwise dispose of, trade, deal in and deal with, import and export any and all classes and kinds of agricultural chemicals, fertilisers, manures there bye-products, mixtures, formulations, intermediates, derivatives and compounds, heavy chemicals, petro-chemicals, petroleum and any petroleum products, fine chemicals and any and all classes and kinds of inorganic and organic chemicals, source materials, intermediates, ingredients, mixtures, derivatives and compounds thereof and any and all kinds of products of which any of the foregoing constitutes an ingredient or in the preparation, formulation, mixtures or production of which any of the foregoing is used or required.
- (20) To carry on the business of manufacturers and dealers in machinery, implements and plant of every description and kind and to manufacture, produce, repair, alter, convert, recondition, prepare for sale, buy, sell, hire, import, export, let out on hire, trade and deal in machine tools and implements, other machinery, plant equipments, articles, apparatus, appliances, component parts, accessories, fittings and things in any stage or degree of manufacture, process or refinement.
- (21) To produce, acquire and trade in sugarcane and other sugar producing materials and covert them into sugar marketable commodities and sell the same in any form, shape or design.
- (22) To produce, acquire and trade in oil or oil seed or their substance from which oil or oily matter can be extracted and convert the same into marketable commodities and sell the same.
- (23) To carry on business as manufactures of and dealers in acids, alkalies and chemicals, pharmaceuticals, medical chemical, industrial and other preparations and articles, compounds, cements, oils, paints, pigments and varnishes, drugs, paints and colours and of electrical, chemical, photographical, surgical and scientific apparatus and materials.
- (24) To carry on business as manufacturers of and dealers in chemicals, fertilisers phosphates, bone product, glue, alumic products and manures, and as distillers, dyemakers gas makers, soap and perfume makers, metallurgists and

mechanical engineers to search for, get works raise, make merchantable, sell and deal in iron, iron-stone, brick earth, bricks and other metals minerals and substances.

- (25) To carry on the business of soap manufacturers and manufacturers of vegetable ghee, refined oil and other vegetable products; to buy, sell, manufacture, refine prepare and deal in all kinds of oil, oligenous and saponaceous and all kinds of ointments, ingredients and toilet requisites perfume etc.
- (26) To carry on and work of the business of cultivators winner and buyers of every kind of vegetable, mineral other produce of the soil including cotton, sugarcane, nuts, perfume-producing vegetarian, etc. to prepare manufacture and render marketable any such produce, and to sell, dispose of and deal in any such produce either in its prepared, manufactured or raw state, and either by wholesale or retail.
- (27) To carry on all or any of the business of printers, stationers, lithographers type foundry; stereotypers electro typers, photographic printers, photo lithographers, chromolithographers, engravers, die sinkers, bookbinders, designers, draughtmen, paper and ink manufacturers, book sellers, publishers, advertising agents, engineers and dealers in or manufacturers of any other articles or things of a character similar or analogous to the foregoing or any of them or connected therewith.
- (28) To carry on business of brewers and maltsters in all its branches and to prepare all kinds of spirits and liquor, whether for human consumption or for use as fuel or otherwise.
- (29) To carry on the business of iron foundry, mechanical engineers and manufacturers of agricultural implements and other machinery, tool makers, brass foundry, metal workers, boiler makers, mill wrights, machinists, iron and steel converters, smiths, wood workers, builders painters, metallurgists, electrical engineers, water supply engineers, gas makers, framers, printers, carriers and merchants, and to buy, sell, manufacture, repair, convert, alter let on hire and merchants, and to buy, sell, manufacture, repair, convert, alter, let on hire and deal in machinery, implements, rolling stock and hardware of all kinds, and to carry on any other business manufacturing or otherwise which may seem to the company capable of being conveniently carried on in connection with the above or otherwise calculated directly or indirectly to enhance the value of the Company's property and rights for the time.
- (30) To carry on any business relating to the winning and working of materials, the production and working of metals and the production, manufacture and preparation of any other material which may be usefully or conveniently combined with the engineering or manufacturing business of the Company.
- (31) To purchase, take on lease or otherwise acquire any mines, mining rights and metalliferous land in India or elsewhere, and any interest therein and to explore, work, exercise, develop and turn to account the same; to crush, win, get quarry smelt, calcine, refine dress, amalgamate, manipulate and prepare for market or metal and mineral substances of all kinds and to carry on any other metallurgical operations which may seem conducive to the Company's objects.
- (32) To carry on the business of producers and suppliers of gas, whether for the purpose of light, heat, motive power, telephonic, telegraphic industrials or other

purposes, and generally to provide work, maintain and carry out all necessary cables, wires, accumulators, lamps, exchanges, telephones and apparatus connected with the generation, distribution, supplying accumulation and employment of electricity or gas.

- (33) To carry on the business of an electric light and power company in all its branches and in particular to lay down construct and carry out all necessary cables, wires, lines, accumulators lamps and works and to generate, accumulate, distribute, and supply electricity for the purposes of light, heat, motive power or otherwise and to carry on the business of mechanical engineers, electricians and manufactures of and dealers in all apparatus and things required for or capable of being used in connection with such business.
- (34) To carry on the business of planters, cultivators, manufacturers, buyers and sellers of tea, tea seed, coffee and in this connection to purchase, take on lease or in exchange or otherwise acquire any lands, tea gardens, plantations and property as the company may think necessary or convenient for its business and to form, open out, work and carry on the business of tea estate or tea estates on any lands to acquire, construct, and maintain factories, establishments, works, buildings and erections for all or any of the purposes aforesaid, and to acquire or make machinery, implements and articles required to be used for any such purposes, to carry on as principals or agents in any branch of agricultural, manufacturing or mercantile for which the Company's lands, tea gardens, establishments, property and employees may be conveniently applicable and to carry on all such business connected with acquisition, hiring, leasing, planting, irrigation and cultivation of lands and the rendering merchantable and disposing of the produce and cultivation of lands and the rendering merchantable and disposing of the produce thereof as are usually or may conveniently be associated with the plantation and cultivation of tea gardens, and the manufacture, export, and sale of tea or any other produce of the soil.
- (35) To carry on the business of producers, manufacturers, purchasers, refiners, importers, exporters, sellers, of and dealers in cement, asbestos products, firebricks, coke, refractories articles, lime and limestone, plasters, artificial stone and materials of every kind used in the manufacture thereof, whiting clay, gravel, sand, sacks, bricks, tiles, building materials analogous to or connected therewith and compounds, products and bye-products or preparation allied thereto and the business of miners, metallurgists, builders, contractors and to purchase and vend all materials raw processed or otherwise and all articles in any way connected with the aforesaid business and in connection therewith to take on lease or acquire, erect, construct, establish, operate and maintain cement factories, quarries and collieries, workshops and other works.
- (36) To purchase, manufacture, produce, grow, refine, prepare, import, export, sell and generally to deal in sugar, sugarcane, sugar beets, mahua, palms, gur, jaggery, molasses, syrups and alcohol and all products or bye-products thereof and food products generally and in connection therewith to acquire, erect, construct establish, operate and maintain sugar or other refineries, buildings, mills, factories, distilleries and other works and to carry on and work the business of growing, cultivating or buying every kind of sugar cane, plants, fruits and seeds and vegetables produce or products of the soil and products of agriculture or husbandry; to prepare, manufacture, crush and render marketable any such sugar-cane plants, fruits, seeds, grain and produce and to sell, dispose of and deal in any sugar, sugar cane plant, fruits, seeds produce and products in their prepared, manufactured or raw state.

- (37) To carry on the business of manufacturers, importers, exporters and dealers in all kinds and classes of paper, board, corrugated board, corrugating medium and pulp and all kinds of articles in the manufacture of which in any form, paper, board or pulp is used and also to deal in or manufacture any other articles or things of a character similar or analogous to the foregoing or any of them or connected therewith and to purchase or otherwise acquire, settle, improve and cultivate forests, lands and properties of any tenure whatsoever with a view to producing, cultivating, growing timber, bamboo or other wood or any other material required for manufacture of paper, board and pulp.

Subject to and in accordance with the provisions of the Act, the Company may issue share warrants in its discretion with respect to any share which is fully paid, upon application in writing, signed by the person registered as holder of the share, and authenticated by such evidence (if any) as the Board may, from time to time, require as to identity of the person signing the application, and on receiving the certificate (if any) of the share, and the amount of the stamp duty on the warrant and such fees as the Board may from time to time require for the issue of a share warrant.

Power to Issue share warrants

(1) The bearer of a share warrant may at any time deposit the warrant at the office of the Company, and so long as the warrant remains so deposited, the depositor shall have the same right of signing a requisition for calling a meeting of the Company, and of attending, and voting and exercising the other privileges of a member at any meeting held after the expiry of two clear days from the time of deposit, as if his name were inserted in the Register of Members as the holder of the share included in the deposited warrant.

Deposit of share warrant

(2) Not more than one person shall be recognised as depositor of the share warrant.

(3) The Company shall, on two days' written notice, return the deposited share warrant to the depositor.

82. (1) Subject a herein otherwise expressly provided, no person shall, as bearer of a share warrant, sign a requisition for calling a meeting of the Company, or attend, or vote or exercise any other privileges of a member at a meeting of the Company or be entitled to receive any notices from the Company.

Privileges and disabilities of the holders of share warrants

(2) The bearer of a share warrant shall be entitled, in all other respects, to the same privileges and advantages as if he was named in the Register of Members as the holder of the share included in the warrant, and he shall be a member of the Company.

83. The Board may, from time to time, make rules as to the terms on which (if it shall think fit) a new share warrant or coupon may be issued by way of renewal, in case of defacement, loss or destruction.

SWEAT EQUITY

84. Subject to the provisions of the Act and Rules made thereunder, the Company may issue sweat equity shares.

BUY-BACK OF SHARES

85. Notwithstanding anything contained in these Articles but subject to all applicable provisions of the Act or any other law for the time being in force, the Company may purchase its own shares or other specified securities. Buy-back of shares

BORROWING POWERS

86. Subject to the provisions of the Act and Rules made thereunder, the Board may, from time to time at its discretion by a resolution passed at a meeting of the Board, accept deposits from members, either in advance of calls or otherwise, and generally raise or borrow or secure the payment of any sum or sums of money for the purposes of the Company. Provided, however, where the moneys to be borrowed together with moneys already borrowed (apart from temporary loans obtained from the company's bankers in the ordinary course of business) exceed the aggregate of the paid-up capital of the Company and its free reserves (not being reserves set apart for any specified purpose), the Board shall not borrow such moneys without the consent of the Company in general meeting by means of a special resolution. Power to borrow
87. The Board may raise or secure the repayment of such sum or sums in such manner and upon such terms and conditions in all respects as it thinks fit and in particular by the issue of bonds, notes, debentures convertible, redeemable or otherwise, perpetual or redeemable debenture-stock or any mortgage or other security on the undertaking of the whole or any part of the property of the Company (both present and future) including its uncalled capital for the time being. Conditions of Borrowing
88. Any debentures, debenture-stock, bonds and other securities may be issued at a discount, premium or otherwise and with any special privileges as to redemption, surrender, drawings, allotment of shares, or conversion, appointment of directors and otherwise. Debentures, debenture-stock, bonds and other securities may be made assignable free from any equities between the Company and the people to whom the same may be issued provided that Debentures, Debenture Stock, bonds or other securities with the right to conversion into or allotment of shares shall be issued only with the consent of the Company in General Meeting. Terms of issue of Debentures. etc.
89. The Board shall keep at its Registered office a Register of Charges in accordance with the provisions of the Act and Rules made thereunder which shall include therein all charges and floating charges affecting any property or assets of the company or any of its undertaking/s, indicating in each case such particulars as may be prescribed. Register of mortgages to be kept

GENERAL MEETINGS OF MEMBERS

90. (1) The Company shall in each year hold a general meeting as its Annual General Meeting in addition to any other meetings in that year and shall specify the meeting as such in the notices calling it. Annual General Meeting
- (2) An Annual General Meeting of the Company shall be held within six months after the closing of each financial year, provided that not more than fifteen months shall elapse between the date of one Annual General Meeting and that of the next.
- (3) Nothing contained in the foregoing provisions shall be taken as affecting the power conferred upon the Registrar under the provisions of of the Act and Rules made thereunder to extend the time within which any Annual General Meeting may be held.

(4) Every Annual General Meeting shall be called for a time during business hours, that is, between 9.00 a.m. And 6.00 p.m., on a day that is not a National Holiday, and shall be held at the registered office of the Company or at some other place within the city, town or village in which the registered office of the Company is situate as the Board may determine.

(5) Every member of the Company shall be entitled to receive notice of the general meetings to attend either in person or by proxy.

(6) The Auditor/s of the Company shall be entitled to receive notice of the general meetings to attend either in person or through his authorized representative, duly qualified, any General Meetings and shall have the right to be heard at such meeting on any part of the business which concerns him as Auditor.

All general meetings other than annual general meeting shall be called extraordinary general meeting.

Extraordinary general meeting

91. The Board may, whenever it thinks fit, call an Extraordinary General Meeting; and it shall on a requisition in writing by such number of members who hold, on the date of the receipt of the requisition, in the aggregate, not less than one tenth of such of the paid-up share capital which carries as at that date the right of voting in regard to the matter in respect of which the requisition has been made, call an extraordinary general meeting of the company within such period as specified in in the Act and Rules made thereunder.

Powers of Board to call extraordinary general meeting

92. Any valid requisition so made by members must state the object or objects of the meeting proposed to be called and must be signed by the requisitionists and be deposited at the office provided that such requisition may consist of several documents in like form each signed by one or more requisitionists.

Requisition of Members to state object of meeting

93. Upon the receipt of any such valid requisition, the Board shall forthwith call an Extra Ordinary General Meeting and if they do not proceed within twenty one days from the date of the requisition being deposited at the office to cause a meeting to be called on a day not later than forty five days from the date of deposit of the requisition, the requisitionists or such of their number as represent either a majority in value of the paid-up share capital held by all of them or not less than one tenth of such of the paid up share capital of the company as is referred to in the Act and Rules made thereunder, whichever is less, may themselves call the meeting but in either case, any meeting so called, shall be held within three months from the date of delivery of the requisition as aforesaid.

On receipt of requisition Directors to call meeting and In default requisitionists may do so

94. (1) Subject to the provisions of the Act and Rules made thereunder, at least twenty one days' notice of every General Meeting, Annual or Extraordinary specifying the place, date, day and the hour of the meeting and the general nature of the business to be transacted thereat, shall be given in the manner provided, to such persons as are under these Articles entitled to receive notice from the Company.

Twenty-one days notice of meeting to be given

Provided that a General Meeting may be called after giving a shorter notice if consent is given in writing or by electronic mode by not less than 95 per cent of the mebers entitled to vote at such meeting.

95. The accidental omission to give any such notice as aforesaid to any of the members or the non-receipt thereof, shall not invalidate any resolution passed at any such meeting.

Omission to give notice not to invalidate a resolution passed

PROCEEDING AT GENERAL MEETING

96. (1)No business shall be transacted at any general meeting unless a quorum of members is present at the time when the meeting proceeds to business.

Presence of Quorum

(2) No business shall be discussed or transacted at any general meeting except election of Chairperson whilst the chair is vacant.

Business confined to election of Chairperson whilst chair vacant

(3) The Quorum for a General Meeting shall be as per the provisions of the Act and Rules made thereunder

Quorum of General Meeting

97. No General Meeting, Annual or Extraordinary, shall be competent to enter upon, discuss or transact any business which has not been mentioned in the notice or notices upon which it was convened.

Meeting not to transact business not mentioned in notice

98. A body corporate being a member shall be deemed to be personally present, if it is represented in accordance with the Act and Rules made thereunder.

Body corporate deemed to be personally present

99. If, at the expiration of half an hour from the time appointed for holding a meeting of the Company, a quorum shall not be present, the meeting, if convened by or upon the requisition of members shall stand dissolved, but in any other case the meeting shall stand adjourned to the same day in the next week or if that day is a public holiday until the next succeeding day which is not a public holiday, at the same time and place or to such other day and at such other time and place in the city or town in which the office of the Company is for the time being situate, as the Board may determine and if at such adjourned meeting a quorum is not present at the expiration of half an hour from the time appointed for holding the meeting, the members present shall be the quorum and may transact the business for which the meeting was called.

If quorum not present, meeting to be dissolved or adjourned

The chairperson of the Company shall preside as Chairperson at every general meeting of the company.

Chairperson of the meetings

100. # If there is no such Chairperson, or if he/she is not present within 15 minutes of the time appointed for holding the meeting, or is unwilling to act as Chairperson of the meeting, the Directors present shall elect one of their members to be Chairperson of the meeting.

Directors to elect a Chairperson

If at any meeting no Director is willing to act as Chairperson or if no Director is present at the time appointed for holding the meeting, the members present shall, by show of hands or poll or electronically, choose one of their members to be Chairperson of the meeting.

Members to elect a Chairperson

On any business at any general meeting, in case of an equality of votes, whether on a show of hands or electronically or on a poll, the Chairperson shall have a second or casting vote.

Casting vote of Chairperson at general meeting

ADJOURNMENT OF MEETING

101. (1) The Chairperson may, suo motu, adjourn the meeting from time to time and from place to place.

Chairperson may adjourn the meeting

(2) No business shall be transacted at any adjourned meeting other than the business left unfinished at the meeting from which the adjournment took place.

Business at adjourned meeting

(3) When a meeting is adjourned for thirty days or more, notice of the adjourned meeting shall be given as in the case of an original meeting.

Notice of adjourned meeting

- (2) Every person (other than a Director retiring by rotation or otherwise or a person who has left at the office of the Company a notice under the provisions of the Act signifying his candidature for the office of the Director) proposed as a candidate for the office of a Director shall sign and file with the Company, the consent in writing to act as a Director, if appointed.

POWERS OF THE BOARD

158. The management of the business of the Company shall be vested in the Board and the Board may exercise all such powers, and do all such acts and things, as the Company is by the memorandum of association or otherwise authorized to exercise and do, and, not hereby or by any statue or otherwise directed or required to be exercised or done only in the general meeting of the Company; provided that no such regulation shall invalidate any prior act of the Board which would have been valid if such regulation would not have been made. General powers of the Company vested in Board
159. The Board may exercise all such powers of the Company and do all such acts and things as are not by the Act or any other Act or by the Memorandum or by the Articles of the Company required to be exercised by the Company in General Meeting; subject nevertheless to these Articles, to the provisions of the Act, or any other Act and to such regulations being not inconsistent with the aforesaid regulations or provisions, as may be prescribed by the Company in General Meeting. No regulation made by the Company in General Meeting, shall Power of Board of Directors

however, invalidate any prior act of the Board which would have been valid if that regulation had not been made.

160. Provided that the Board shall not, except with the consent of the Company in General Meeting, exercise its powers which are expressly required to be exercised except with the consent of the shareholders in the general meeting:

(a) sell, lease or otherwise dispose of the whole, or substantially the whole, of the undertaking of the Company, or where the Company owns more than one undertaking of the whole, or substantially the whole of any such undertaking;

(b) remit or give time for the repayment of, any debt due by a Director;

(c) to invest otherwise in trust securities the amount of compensation received by it as a result of any merger or amalgamation;

(d) borrow moneys where the moneys to be borrowed together with the moneys already borrowed by the Company (apart from temporary loans obtained from the Company's bankers in the ordinary course of business), will exceed the aggregate of the paid up capital of the Company and its free reserves that is to say, reserves not set apart for any specific purpose. Provided further that the powers specified in the Act and Rules made thereunder, shall subject to these Articles be exercised only at meetings of the Board. unless the same be delegated to the extent therein stated; or

(e) contribute to bona fide and charitable and other funds, any amounts, the aggregate of which will, in any financial year, exceed five per cent of its average net profits for the three immediately preceding financial years.

161. Subject to the provisions of the Act and the Rules made thereunder, the company may engage in corporate social responsibility (CSR) activities, with such regulatory oversight as the Board may deem fit.

CSR Activities of the Company

162. Without prejudice to the generality of the powers conferred by the last preceding Articles and so as not in any way to limit or restrict those powers and without prejudice to the other powers conferred by these Articles and by the Act (but subject to the restrictions if any, contained in the last preceding Articles or the Act), it is hereby declared that the Directors shall have the following powers, that is to say, power:-

(1) To pay the costs, charges and expenses preliminary and incidental to the promotion, formation, establishment and registration of any entity (including body corporate), in which the company is interested.

(2) To pay and charge to the capital growth account of the Company commission or Interest lawfully payable thereout under the provisions of the Act and Rules made thereunder.

(3) Subject to the provisions of the Act and Rules made thereunder, to purchase or otherwise acquire for the Company any property, rights or privileges which the Company is authorised to acquire, at or for such price or consideration and generally on such terms and conditions as they think fit; and in any such purchase or other acquisition to accept such title as the Directors may believe or may be advised to be reasonably satisfactory.

(4) At their discretion and subject to the provisions of the Act to pay for any property, rights or privilege acquired by or services rendered to the Company either wholly or partially, in cash or in shares, bonds, debentures, mortgages or other securities of the Company, and any such shares, may be issued either as fully paid up or with such amount credited as paid up thereon as may be agreed

upon, and any such bonds, debentures, mortgages or other securities may be either specifically charged upon all or any part of the property of the Company and its uncalled capital or not so charged.

(5) To secure the fulfilment of any contracts or engagements entered into by the Company by mortgage or charge of all or any of the property of the Company and its uncalled capital for the time being on in such manner as they may think fit.

(6) To accept from any member, as far as may be permissible by law, a surrender of his shares or any part thereof on such terms and conditions as shall be agreed.

(7) To appoint any person to accept and hold in trust for the Company any property belonging to the Company in which it is interested, or for any other purposes; and to execute and do all such deeds and things as may be required in relation to any trust, and to provide for the remuneration of such trustee or trustees.

(8) To institute, conduct, defend, compound or abandon any legal proceeding by or against the Company or its officers, or otherwise concerning the affairs of the Company, and also to compound and allow time for payment or satisfaction of any debts due and of any claim or demands by or against the Company and to refer any differences to arbitration and observe and perform any awards made thereon.

(9) To act on behalf of the Company in all matters relating to bankrupts and insolvents.

(10) To make and give receipts, releases and other discharges for moneys payable to the Company and for the claims and demands of the Company.

(11) Subject to the provisions of the Act and Rules made thereunder, to invest and deal with any moneys of the Company not immediately required for the purposes thereof upon such security (not being shares of this Company) or without security and in such manner as they may think fit, and from time to time to vary or realise such Investments. Save as provided in the Act and Rules made thereunder, all investments shall be made and held in the Company's own name.

(12) To execute in the name and on behalf of the Company in favour of any Director or other person Who may incur or be about to incur any personal liability whether as principal or surety, for the benefit of the Company, such mortgages of the Company's property (present and future) as they think fit and any such mortgage may contain a power of sale and such other powers, provisions covenants and agreements as shall be agreed upon.

(13) To determine from time to time who shall be entitled to sign, on the Company's behalf, bills, notes, receipts, acceptances, endorsements, cheques, dividend warrants, releases, contracts and documents and to give the necessary authority for such purpose.

(14) To distribute by way of bonus amongst the staff of the Company a share or shares in the profits of the Company, and to give to any officer or other person employed by the Company a commission on the profits of any particular business or transaction; and to charge such bonus or commission as part of the working expenses of the Company.

(15) To provide for the welfare of Directors or ex-Directors or employees or ex-employees of the Company and their wives, widow and families or the dependents or connections of such persons, by building or contributing to the building of houses; dwellings or chawls, or by grants of money pension,

gratuities. Allowance, bonus or other payments, or by creating, and from time to time subscribing or contributing to provident and other associations, institutions, funds or trusts and by providing or subscribing or contributing towards places of instruction and recreation, hospitals and dispensaries, medical and other attendance and other assistance as the Board shall think fit and to subscribe or contribute or otherwise to assist or to guarantee any charitable, benevolent, religious, scientific, national or other institutions or objects which shall have any moral or other claim to support or aid by the Company, either by reason of locality of operation or of public and general utility or otherwise.

(16) Before recommending any dividend, to set aside out of the profits of the Company such sums as they may think proper for depreciation or to Depreciation Fund. or to an Insurance Fund, or as Reserve Fund or Sinking Fund or any special fund to meet, contingencies or to repay debentures or debenture-stock, or for special dividends or for equalising dividends or for repairing, improving, extending and maintaining any of the property of the Company and for such other purposes (including the purpose referred to in the preceding clause), as the Board may, in its absolute discretion, think conducive to the interest of the company, and subject to the provisions of the Act, to invest the several sums so set aside or so much thereof as require to be invested, upon such investments (other than shares of the Company) as they may think fit, and from time to time to deal with and vary such investments and dispose of and apply, and expend all or any part thereof for the benefit of the Company, in such manner and for such purposes as the Board in their absolute discretion, think conducive to the interest of the Company, notwithstanding that the matters to which the Board apply or upon which they expend the same, or any part thereof, may be matters to or upon which the moneys of the Company might rightly be applied or expended; and to divide the Reserve Fund into special funds as the Board may think fit, with full power to transfer the whole or any portion of a Reserve Fund or division of a Reserve Fund or another Reserve Fund or division of a Reserve Fund and with full power to employ the assets constituting all or any of the above funds, including the Depreciation Fund, in the business of the Company or in the purchase or repayment of debentures or debenture stock and without being bound to pay interest on the same with power however to the Board at their discretion to pay or allow to the credit of such funds interests at such rate as the Board may think proper.

(17) To appoint, and at their discretion remove or suspend such managers, secretaries, assistants, supervisors, clerks, agents and servants for permanent, temporary or special services as they may from time to time think fit, and to determine their power and duties and fix their salaries or emoluments or remuneration, and to require security in such instances and to such amount as they may think fit. And also from time to time to provide for the management and transaction of the affairs of the Company in any specified locality in India or elsewhere in such manner as they think fit; and the provision contained in the four next following sub-clauses shall be without prejudice to the general powers conferred by this Sub-clause.

(18) To comply with the requirements of any local law Which in their opinion it shall In the Interests of the Company be necessary or expedient to comply with.

(19) From time to time and at any time to establish any local Board for Managing any of the affairs of the Company in any specified locality in India or elsewhere and to appoint any persons to be members of such Local Boards and to fix their remuneration.

(20) Subject to the provisions of the Act and Rules made thereunder, from time to time and at any time delegate to any person so appointed any of the powers, authorities and discretions for the time being vested in the Board other than their

power to make calls or to make loans or borrow moneys, and to authorise the members for the time being of any such Local Board. or any of them to fill up any vacancies therein and to act notwithstanding vacancies, and any such appointment or delegation may be made on such terms and subject to such conditions as the Board may think fit, and the Board may at any time remove any person so appointed, and may annul or vary any such delegation.

(21) At any time and from time to time by Power of Attorney under the Seal of the Company to appoint any person or persons to be the Attorney or Attorneys of the Company, for such purposes and with such powers, authorities and discretions (not exceeding those vested In or exerciseable by the Board under these presents and subject to the provisions of the Act and Rules made thereunder) and for such period and subject to such conditions as the Board may from time to time think fit; and any such appointment may (if the Board thinks fit) be made in favour of the members or any of the members of any local Board established as aforesaid, nominees or managers of any company or firms or otherwise in favour of any fluctuating body of persons whether nominated directly or Indirectly by the Board and any such Power of Attorney may contain such powers for the protection or convenience of persons dealing with such Attorneys as the Board may think fit, and may contain powers enabling any such delegates or attorneys as aforesaid to sub-delegate all or any of the powers, authorities and discretion for the time being vested In them. The Attorney and agents may also be appointed for management of the Company's affairs abroad.

(22) Subject to the provisions of the Act and Rules made thereunder, for or in relation to any of the matters aforesaid or otherwise for the purposes of the Company to enter into all such negotiations and contracts and rescind and vary all such contracts, and execute and do all such acts, deeds and things in the name and on behalf of the Company as they may consider expedient.

(23) From time to time, in accordance with the Act or any other Rules in force, to make and/or cause to be made, amend, vary, abrogate and repeal, any articles, bye-laws, rules and regulations concerning the administration and management and business of the Company, and Its officers and servants.

163. 1. Except with the consent of the Board of Directors given by the resolution at a meeting of the Board and subject to such conditions as stipulated in the Act and Rules made thereunder, the company may not enter into transactions with a Related Party as defined in the Act and Rules made thereunder. Director or related party may contract with Company, subject to the Act
2. If the contract or arrangement exceed such sums as prescribed under the rules made under the Act, then such contract or arrangement shall not be entered into, except with the prior approval of the company by a special resolution in which special resolution, no member of the company, shall vote, if such member is considered a related party in respect of that contract or arrangement, which may be entered into by the company.
3. Nothing aforesaid shall apply to any transactions or contracts or arrangements entered into by the company, if such transaction or contract or arrangement are in the ordinary course of business other than transactions / contracts / arrangements which are not on an arm's length basis.
164. Subject to the provisions of the Act and Rules made thereunder, the Company or any of its units, under the superintendence, direction and control of the Board or of its committee, shall advance any loan or inter-corporate deposits to any of its directors or to any other person in whom the director is interested or give any guarantee or provide any security in connection with any loan taken by him or such other person, in its ordinary course of business, after charging interest at a rate not less than the bank rate declared by the Reserve Bank of India. Loans to Directors, etc.

MANAGEMENT

181. The Company may appoint Managing or Whole time Director/Directors or Manager to manage its affairs for such period and on such remuneration and upon such terms and conditions and in the manner required by the Act as may be sanctioned by the Company as approved by the Central government wherever necessary. Any Managing Director/Wholetime Director so appointed shall not be liable to retire at any general meeting of the Company.

The Board may appoint Managing/ Wholetime Director

182. Subject to the provisions and the superintendence of the Board, the Managing Director shall have the management of the affairs of the Company. Subject to the provisions of law and requisite permission/approvals of the Shareholders and Central Government, wherever required the remuneration of the Managing Director/Wholetime Director shall be such as may be determined by the Board from time to time and may be by way of monthly payment, fee for each meeting or participation in profits or by any or all these modes or any other mode not expressly prohibited by the Act.

183. The Company shall not appoint or employ at the same time more than one of the following categories of managerial personnel, namely:-

Prohibition of simultaneous appointment of different categories of managerial personnel

- (a) Managing Director
- (b) Manager

SEAL

184. (a) The Board shall provide a Common Seal for the purposes of the Company and shall have power from time to time to destroy the same and substitute a new Seal in lieu thereof and the Board shall provide for the safe custody of the Seal for the time being and the Seal shall never be used except by the authority of the Board or a Committee of the Board previously given. The seal, its custody and use
- (b) The Company shall also be at liberty to have an official Seal for use in any territory, district or place outside India.
185. (1) Every deed or other instrument to which the Seal of the Company is required to be affixed shall be signed by one Director provided that in respect of the Share Certificate the Seal shall be affixed in accordance with the provisions of the Act. Any instrument bearing the Seal of the company and issued for valuable consideration shall be binding on the Company notwithstanding any irregularity touching the authority of the Directors to issue the same. - (2) The seal of the company shall not be affixed to any instrument except by the authority of a resolution of the Board or of a committee of the Board authorised by it in that behalf, and except in the presence of at least one Director or the manager, if any, or of the secretary or such other person as the Board may appoint for the purpose; and such directors or manager or the secretary or the other person aforesaid shall sign every instrument or other person aforesaid shall sign every instrument to which the seal of the company is so affixed in their presence. Chief Executive Officer, Manager, Company Secretary, and Chief Financial Officer

186. Subject to the provision of the Act,-
- (a) A chief executive officer, manager, company secretary, and chief financial officer may be appointed by the Board for such term ,at such remuneration and upon such conditions as it may think fit , and chief executive officer , manager, company secretary and chief financial officer so appointed may be removed by means of a resolution of the Board; the Board may appoint one or more chief executive officer for its multiple business. Chief Executive officer,
- (b) A director may be appointed ac chief executive officer, manager, company secretary or chief financial officer. Directors may be chief executive officer, etc.

REGISTER

187. The company shall keep and maintain at its registered office all statutory registers, namely register of charges, register of members, register of debenture holders ,register of any other security holder, and the register and index of beneficial owners, and annual return, register of loan ,guarantees, security and acquisitions, register of investments not held in its own name and register of contracts and arrangements for such duration as the Board may unless otherwise prescribe ,decide ,and in such manner and containing such particulars as prescribed by the Act and the Rules .The registers and copies of annual return shall be open for inspection during 11.00 a.m to 1.00 p.m on all working days, other then Saturday , at the registered office of the company by the person entitled thereto on payment ,where required, of such fees as may be fixed by the Board but not exceeding the limit prescribed by the Rules. Statutory Registers
188. (a) The company may exercise the powers conferred on it by the Act with regards to the keeping of a foreign register; and the Board may (subject to the provision of the Act)make and vary such regulations as it thins fit respecting the keeping of any such register. Foreign register

(b) The foreign register shall be open for inspection and may be closed, and extracts may be taken therefrom and copies thereof may be required, in the same manner, mutatis mutandis, as is applicable to the register of members.

DOCUMENTS AND NOTICE

189. A document or notice may be served or given by the Company on any member either personally or by sending it by post or by courier service to him to his registered address or (if he has no registered address in India) to the address, if any, in India supplied by him to the Company for serving documents or notices on him or by such electronic or other mode as prescribed in the Act. Service of documents or notices on Members by Company.
190. Where a document or notice is sent by post or by courier service or by such electronic or other mode as prescribed in the Act, service of the document or notice shall be deemed to be effected by properly addressing, preparing and posting a letter containing the document or notice provided that where a member has intimated to the Company in advance that documents or notices should be sent to him under a certificate of posting or by registered post with or without acknowledgement due and has deposited with the Company a sum sufficient to defray his expenses of doing so; service of the document or notice shall not be deemed to be effected unless it is sent in the manner intimated by the member and such service shall be deemed to have been effected in the case of a Notice of a meeting, at the expiration of forty eight hours after the letter containing the document or notice is posted and in any other case, at the time at which the letter would be delivered in the ordinary course of post.
191. A document or notice advertised in a newspaper circulating in the neighbourhood of the Office shall be deemed to be duly served or sent on the day on which the advertisement appears on or to every member who has no registered address in India and has not supplied to the Company an address within India for the serving of documents on or the sending of notices to him. By Advertisement
192. A document or notice may be served or given by the Company on or to the joint-holders of a Share by serving or giving the document or notice on or to the joint holder named first in the Register of Members in respect of the share On joint-holder
193. A document or notice may be served or given by the Company on or to the persons entitled to a share in consequence of the death or Insolvency of a member by sending it through the post in prepaid letter addressed to them by name or by the title of representatives of the deceased, or assignee of the insolvent or by any like description, at the address (if any) in India supplied for the purpose by the persons claiming to be entitled, or (until such an address has been so supplied) by serving the document or notice in any manner in which the same might have been given if the death or insolvency had not occurred. 194. Documents or notices of any General Meeting shall be served or given in same manner hereinbefore authorised or to (a) every member (b) every person entitled to a share in consequence of the death or insolvency of a member, and (c) the Auditor or Auditors for the time being of the Company. To whom documents or notice must be served or given
195. Every person who, by operation of law, transfer or other means whatsoever, shall become entitled to any share, shall be bound by every document or notice in respect of such share, which previously to his name and address being entered on the Register of members, shall have been duly served on or given to the person from whom he derives his title to such shares. Members bound by documents or notices served on or given to previous holders
